##### Please note:

**Any entries not received by or on the closing date (30 June 2025) will not be accepted.**  
**Any entry or event packages not received by or on 10 July 2025 will result in the entry being cancelled.**  
**Any outstanding membership or championship invoices as of 10 July 2025 will result in the entry being cancelled.**

##### How to enter

Only entries from ESF member nations will be accepted. **We ask that Clubs enter online through the Member Nation as individual clubs cannot access the software.** Please enter online at [ESF website calendar](#) Complete your hotel and travel information using the spreadsheet and send directly to the host: [<stefan@heroes-squash.at>](mailto:stefan@heroes-squash.at)

The online entry must be submitted by **30 June 2025**. The package information must be submitted to the host by **10 July 2025**. Enter squads online by **24 August 2025**.

### **European Squash ID (ESID)**

All players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported. Register for a ESID through the ESF tournament software website: <https://esf.tournamentsoftware.com>

### **Coaches**

All team or individual player coaches designated by their nation as part of their event onsite management team (solely, or in attendance with an appointed team manager) at any Championship held under the auspices of ESF must be ESF Registered i.e. have a ESID as their licence to attend in a formal representative role. This is required at the time of them being registered to attend by their national federation.

### **Withdrawals**

In the event of a withdrawal from the Championships, after the closing date, penalty fees additional to the entry fee will apply in accordance with Regulations Section A.

### TRANSPORT

The organisers will provide transport between designated arrival/departure points and the Championships Hotel.

The designated arrival / departure points for participants with a Hotel package are:  
Airport Graz and Graz main railway station (Graz Hauptbahnhof).

The shuttle service from the hotel to the venue during the tournament is only covered by a package deal.

### ELIGIBILITY

Player eligibility for the Championships is shown in Regulations - Section B2 and Section U.

### SEEDING AND DRAWS

The seeding and draw will be carried out by the Seeding Panel under the direction of the Event Director and in accordance with Section U2 of the Championships Regulations. Member nations have no right of appeal against final seeding or draws.

### PRACTICE COURTS

Practice facilities will be provided at no cost by the organiser and will be available at the venue starting the day before the Championships (Regulations – Section F6).

### REFEREES

Qualified referees will be provided in accordance with ESF Referee Committee procedures relating to the specific Championships and Regulations - Section F9.

### SCORING

PAR 11 scoring will be used (to 2 clear points).

### SQUASH BALLS

The Dunlop PRO XX ball will be used.





#### **CHAMPIONSHIPS OFFICE**

The Championships Office will be located at the venue and will be open from 09:00 until close of play every day of the Championships.

#### **DOPE TESTING**

The ESF and the hosts reserve the right to implement compulsory dope testing for any player participating in the Championships. Dope testing may be carried out in line with the doping regulations published by the WSF. Member nations are responsible for informing all their participants (including managers, coaches and physiotherapists) about the latest WSF policy on doping; and must impose the standard WSF suspension from all forms of competitive squash upon a player who has used banned substances or practices.

#### **INSURANCE AND RISKS**

Players enter and play in the Championships at their own risk. Neither the ESF, the Host Association, the Host Club nor the Organisers will accept any responsibility for injury or other damages arising from participation in the Championships. ESF recommends that all officials and participants have full travel, medical and possessions insurance when travelling to any Championships.

#### **EYE PROTECTION**

All junior players (under 19 years of age) must wear protective eyewear (manufactured to an approved national safety standard) properly over the eyes at all times during practice and match play. The list of WSF Certified Eyewear allowable at the time of participation can be viewed on the WSF website.

#### **CLOTHING AND ADVERTISING**

The ESF clothing and advertising regulations will be adhered to. In all matters of judgement or opinion arising from the interpretation of this clothing regulation, the decision of the Championships Referee shall be final (Regulations – Section P).

#### **VISA PROCEDURES**

Please note that visas may be required to enter Austria. It is the responsibility of the member nation to ensure all players and officials have the appropriate documentation and that visas are applied for in good time before the Championships.

#### **PRIVACY POLICY**

The tournament shall be run under the terms and conditions as set out in EUROPEAN SQUASH FEDERATION PRIVACY POLICY as published on the ESF website [www.europeansquash.com](http://www.europeansquash.com)

The team will be publishing draws, results, photos of players as well as live footage from matches, players and the venue. As this is part of the tournament regulations, ESF will deem that players/managers/coaches and officials have accepted these regulations by entering the tournament.
